# Surat Keterangan Tempat Tinggal WHY AND HOW TO APPLY IN DENPASAR BALI

## What is an SKTT?

SKTT is a temporary civil registration document for KITAS/KITAP holders. Consider it as a national identification card for expats in Indonesia. It contains a NIK number. NIK is a national registration number.

## What is it needed for?

Well, according to the laws and regulations in Indonesia every KITAS/KITAP holder is required to obtain it, mandatory.

You should apply for it straight after your KITAS/KITAP has officially been approved by immigration.

A few visa agents are on the current about this but most are not.

Basically you need it for nothing.

THOUGH

Since the Covid-vaccination-program has been launched you will need your SKTT/NIK to get your jabs.

Only expats with a verified (!) 16 digits NIK number will be acknowledged to download the final internationally recognised vaccination certificate.

## **HOW TO GET IT?**

There are a few steps. Don't worry. It's easier than you think.

Main issues: make sure that you have an account at the site of Civil Affairs Denpasar and prepare your required docs for upload.

# STEP 1 CREATING AN ACCOUNT

Be sure you do this before 11am on working days.

You will receive a verification/confirmation email ... after some time.

Your kepala desa will only issue a Surat Keterangan by presenting him SURAT TANDA MELAPORKAN. That is a document you apply for at your closest police station. In theory this police document is supposed to be gratis, free of charge. In reality most police offices will charge you, illegally. You might avoid their charge by stating that you want a bon in return. In most cases they will drop the charge.

#### 8.2 KTP sponsor

Your sponsor doesn't need to be your KITAS/KITAP sponsor. The only requirement: he/she needs to be registered in the same area as you are. So, even your landlord or other local friend can be your sponsor for SKTT.

### 8.3 KK sponsor

Make 8.1 8.2 and 8.3 ONE document. Cause you won't be able to upload more than 1 doc in this section later on.
